(i)		The Appellant Player/Club must also lodge a completed Player Appeal Form together with a copy of the latest Refused Clearance application for the player in addition to the Appeal bond.		
(j)		The defendant club must also lodge a bond of \$550 (inc GST) and such bond may be forfeited should the defence be considered frivolous. A \$250 (inc. GST) administrative fee will be retained from the Appeal bond.
